Advisory Body Vacancies: Consider applicants and make appointments to fill an unexpired vacancy on the Environmental Quality Commission

Recommendation

Staff recommends the City Council consider applicants for appointment to an unexpired vacancy on the Environmental Quality Commission (EQC).

Policy Issues

City Council Policy CC-24-004 (Attachment A) establishes the policies, procedures, roles and responsibilities for the City's appointed advisory bodies, including the manner in which members are selected.

Background

Due to a commissioner resignation, the EQC has an unexpected vacancy which should be filled before the next annual recruitment in April 2027. The vacancy will expire April 30, 2028.

To fill the vacancy, the city clerk's office conducted a special recruitment from May 18 – June 12, which included digital advertisements in English and Spanish, announcements at public meetings and reaching out to past applicants, culminating in a total of eight applications received.

Following City Council's appointment, the city clerk's office will provide onboarding and orientation for the new commissioner. This includes the oath of office, commissioner handbook, introduction of advisory body liaison staff, Form 700 Statement of Economic Interests filing (if applicable) and a copy of the Brown Act.

Analysis

Pursuant to City Council Policy CC-24-004, members must be residents of the City of Menlo Park and serve designated terms of four years or through the completion of an unexpired term or as otherwise designated.

Residency for all applicants has been verified by the city clerk's office. In addition, CC-24-004 states the selection/appointment process by the City Council shall be conducted open to the public. Nominations will be made and a vote will be called for each nomination in the order received. Applicants receiving the highest number of affirmative votes from a majority of the City Council present shall be appointed. The number of votes for each City Councilmember is limited to the number of vacancies.

The city clerk's office has compiled all applications received and attached them to this staff report as Attachment B, with the applicants' personal contact information redacted. The redacted applications are also available for public viewing at City Hall during regular business hours or by request. Additionally,

unredacted versions of the applications were made available to the City Council for reference, as applicants were encouraged to contact the City Council to discuss their interest in serving on an advisory body ahead of the June 23 City Council meeting. Table 1 lists all applicants and their residency District. Table 2 lists currently seated members and their residency District.

Purpose
To define policies and procedures and roles and responsibilities for Menlo Park appointed commissions and committees.
Authority
Upon its original adoption, this policy replaced the document known as "Organization of Advisory Commissions of the City of Menlo Park."
Background
The City of Menlo Park currently has seven active Commissions. The active advisory bodies are: Complete Streets Commission, Environmental Quality Commission, Finance and Audit Commission, Housing Commission, Library Commission, Parks and Recreation Commission, and Planning Commission. Those not specified in the City Code are established by City Council ordinance or resolution. Most of these advisory bodies are established in accordance with Resolution No. 2801 and its amendments. Within specific areas of responsibility, each advisory body has a primary role of advising the City Council on policy matters or reviewing specific issues and carrying out assignments as directed by the City Council or prescribed by law. Six of the seven commissions listed above are advisory in nature. The Planning Commission is both advisory and regulatory and organized according to the City Code (Ch. 2.12) and State statute (Government Code §65100 et seq., §65300-65401). The City has an adopted Anti-Harassment and Non-Discrimination Policy (CC-21-0022), and a Travel, Meal, and Lodging Policy (CC-19-002), which are also applicable to all advisory bodies.
Policies and Procedures
<u>Relationship to City Council, staff and media</u> • Upon referral by the City Council, the commission/committee shall study referred matters and return their recommendations and advise to the City Council. With each such referral, the City Council may authorize the City staff to provide certain designated services to aid in the study. • Upon its own initiative, the commission/committee shall identify and raise issues to the City Council's attention and from time to time explore pertinent matters and make recommendations to the City Council. • At a request of a member of the public, the commission/committee may consider appeals from City actions or inactions in pertinent areas and, if deemed appropriate, report and make recommendations to the City Council. • Each commission/committee is required to develop an annual work plan which will be the foundation for the work performed by the advisory body in support of City Council annual work plan. The plan, once finalized by a majority of the commission/committee, will be formally presented to the City Council for direction and approval no later than September 30 of each year and then reported out on by a representative of the advisory body at a regularly scheduled City Council meeting at least annually, but recommended twice a year. The proposed work plan must align with the City Council's adopted work plan. When modified, the work plan must be taken to the City Council for approval. The Planning Commission is exempt from this requirement as its functions are governed by the Menlo Park municipal code (Chapter 2.12) and State law (Government Code §65100 et seq., §65300-65401). • Commissions and committees shall not become involved in the administrative or operational matters of City departments. Members may not direct staff to initiate major programs, conduct large studies or establish department policy. City staff assigned to furnish staff services shall be available to provide general staff assistance, such as preparation of agenda/notice materials and minutes, general review of department programs and activities, and to perform limited studies, program reviews, and other services of a general staff nature. Commissions/Committees may not establish department work programs or determine department program priorities. The responsibility for setting policy and allocating scarce City resources rests with the City's duly elected representatives, the City Council. • Additional or other staff support may be provided upon a formal request to the City Council. • The staff liaison shall act as the commission/committee's lead representative to the media concerning matters before the commission/committee. Commission/Committee members should refer all media inquiries to their respective liaisons for response. Personal opinions and comments may be expressed so long as the commission/committee member clarifies that their statements do not represent the position of the City Council. • Commission/Committee members will have mandatory training every two years regarding the Brown Act and

parliamentary procedures, anti-harassment training, ethics training, and other training required by the City Council or State Law. The commission/committee members may have the opportunity for additional training, such as training for chair and vice chair. Failure to comply with the mandatory training will be reported to the City Council and may result in replacement of the member by the City Council.

- Requests from commission/committee member(s) determined by the staff liaison to take one hour or more of staff time to complete, must be directed by the City Council.

Role of City Council commission/committee liaison

City Councilmembers are assigned to serve in a liaison capacity with one or more city commission/committee. The purpose of the liaison assignment is to facilitate communication between the City Council and the advisory body. The liaison also helps to increase the City Council's familiarity with the membership, programs and issues of the advisory body. In fulfilling their liaison assignment, City Councilmembers may elect to attend commission/committee meetings periodically to observe the activities of the advisory body or simply maintain communication with the commission/committee chair on a regular basis.

City Councilmembers should be sensitive to the fact that they are not participating members of the commission/committee, but are there rather to create a linkage between the City Council and commission/committee. In interacting with commissions/committee, City Councilmembers are to reflect the views of the City Council as a body. Being a commission/committee liaison bestows no special right with respect to commission/committee business.

Typically, assignments to commission/committee liaison positions are made at the beginning of a City Council term in December. The Mayor will ask City Councilmembers which liaison assignments they desire and will submit recommendations to the full City Council regarding the various committees, boards, and commissions which City Councilmembers will represent as a liaison. In the rare instance where more than one City Councilmember wishes to be the appointed liaison to a particular commission, a vote of the City Council will be taken to confirm appointments.

City Staff Liaison

The City has designated staff to act as a liaison between the commission/committee and the City Council. The City shall provide staff services to the commission/committee which will include:

- Developing a rapport with the Chair and commission/committee members
- Providing a schedule of meetings to the city clerk's office and commission/committee members, arranging meeting locations, maintaining the minutes and other public records of the meeting, and preparing and distributing appropriate information related to the meeting agenda.
- Advising the commission/committee on directions and priorities of the City Council.
- Informing the commission/committee of events, activities, policies, programs, etc. occurring within the scope of the commission/committee's function.
- Ensuring the city clerk is informed of all vacancies, expired terms, changes in offices, or any other changes to the commission/committee.
- Providing information to the appropriate appointed official including reports, actions, and recommendations of the committee/commission and notifying them of noncompliance by the commission/committee or chair with City policies.
- Ensuring that agenda items approved by the commission/committee are brought forth in a timely manner taking into consideration staff capacity, City Council priorities, the commission/committee work plan, and other practical matters such as the expense to conduct research or prepare studies, provided appropriate public notification, and otherwise properly prepare the item for commission/committee consideration.
- Take action minutes; upon agreement of the commission, this task may be performed by one of the members (staff is still responsible for the accuracy and formatting of the minutes)
- Maintain a minute book with signed minutes

Recommendations, requests and reports

As needed, near the beginning of City Council meetings, there will be an item called "Advisory Body Reports." At this time, commissions/committees may present recommendations or status reports and may request direction and support from the City Council. Such requests shall be communicated to the staff liaison in advance, including any written materials, so that they may be listed on the agenda and distributed with the agenda packet. The materials being

provided to the City Council must be approved by a majority of the commission/committee at a commission/committee meeting before submittal to the City Council. The City Council will receive such reports and recommendations and, after suitable study and discussion, respond or give direction.

City Council referrals

The city clerk shall transmit to the designated staff liaison all referrals and requests from the City Council for advice and recommendations. The commissions/committees shall expeditiously consider and act on all referrals and requests made by the City Council and shall submit reports and recommendations to the City Council on these assignments.

Public appearance of commission/committee members

When a commission/committee member appears in a non-official, non-representative capacity before the public, for example, at a City Council meeting, the member shall indicate that they are speaking only as an individual. This also applies when interacting with the media and on social media. If the commission/committee member appears as the representative of an applicant or a member of the public, the Political Reform Act may govern this appearance. In addition, in certain circumstances, due process considerations might apply to make a commission/committee member's appearance inappropriate. Conversely, when a member who is present at a City Council meeting is asked to address the City Council on a matter, the member should represent the viewpoint of the particular commission/committee as a whole (not a personal opinion).

Disbanding of advisory body

Upon recommendation by the Chair or appropriate staff, any standing or special advisory body, established by the City Council and whose members were appointed by the City Council, may be declared disbanded due to lack of business, by majority vote of the City Council.

Stipends

Per Government Code §36506, the City is authorized to pay appointed Planning Commissioners by resolution. The City Council has adopted a resolution with an amount not to exceed \$200 per month per Planning Commissioner. Per the IRS (Internal Revenue Services), "public officer" also includes appointed members of advisory boards and committees and commissions. The Planning Commission stipend is taxable income and each member will receive a W-2.

Meetings and officers

1. *Agendas/notices/minutes*

- All meetings shall be open and public and shall conduct business through published agendas, public notices and minutes and follow all of the Brown Act provisions governing public meetings. Special, canceled and adjourned meetings may be called when needed, subject to the Brown Act provisions.
- Support staff for each commission/committee shall be responsible for properly noticing and posting all regular, special, canceled and adjourned meetings. Copies of all meeting agendas, notices and minutes shall be provided to the City Council, city manager, city attorney, city clerk and other appropriate staff, as requested.
- Original agendas and minutes shall be filed and maintained by support staff in accordance with the City's adopted records retention schedule.
- The official record of the commissions/committees will be preserved by preparation of action minutes.

2. *Conduct and parliamentary procedures*

- Unless otherwise specified by State law or City regulations, conduct of all meetings shall generally follow Robert's Rules of Order.
- A majority of commission/committee members shall constitute a quorum and a quorum must be seated before official action is taken.
- The chair of each commission/committee shall preside at all meetings and the vice chair shall assume the duties of the chair when the chair is absent.
- The role of the commission/committee chair (according to Roberts Rules of Order): To open the session at the time at which the assembly is to meet, by taking the chair and calling the members to order; to announce the business before the assembly in the order in which it is to be acted upon; to recognize members entitled to the floor; to state and put to vote all questions which are regularly moved, or necessarily arise in the course of the proceedings, and to announce the result of the vote; to protect the assembly from annoyance from evidently frivolous or dilatory motions by refusing to recognize them; to assist in the expediting of business in every compatible with the rights of the members, as by allowing brief remarks when undebatable motions are pending, if they think it advisable; to restrain the members when engaged in debate, within the rules of order, to enforce on all occasions the observance of order and decorum among the members, deciding questions

of order (subject to an appeal to the assembly by any two members) unless when in doubt he prefers to submit the question for the decision of the assembly; to inform the assembly when necessary, or when referred to for the purpose, on a point of order to practice pertinent to pending business; to authenticate by their signature, when necessary, all the acts, orders, and proceedings of the assembly declaring it will and in all things obeying its commands.

3. *Lack of a quorum*

- When a lack of a quorum exists at the start time of a meeting, those present will wait 15 minutes for additional members to arrive. If after 15 minutes a quorum is still not present, the meeting will be adjourned by the staff liaison due to lack of a quorum. Once the meeting is adjourned it cannot be reconvened.
- The public is not allowed to address those commissioners present during the 15 minutes the commission/committee is waiting for additional members to arrive.
- Staff can make announcements to the members during this time but must follow up with an email to all members of the body conveying the same information.
- All other items shall not be discussed with the members present as it is best to make the report when there is a quorum present.

4. *Meeting locations and dates*

- Meetings shall be held in designated City facilities, as noticed.
- All commissions/committees with the exception of the Planning Commission, and Finance and Audit Commission shall conduct regular meetings once a month. Special meetings may also be scheduled as required by the commission/committee. The Planning Commission shall hold regular meetings twice a month and the Finance and Audit Commission shall hold quarterly meetings.
- Monthly regular meetings shall have a fixed date and time established by the commission/committee. Changes to the established regular dates and times are subject to the approval of the City Council. An exception to this rule would include any changes necessitated to fill a temporary need in order for the commission/committee to conduct its meeting in a most efficient and effective way as long as proper and adequate notification is provided to the City Council and made available to the public.

The schedule of Commission meetings is as follows:

- Complete Streets Commission – Every second Wednesday at 6:30 p.m.
- Environmental Quality Commission – Every third Wednesday at 6 p.m.
- Finance and Audit Commission – Third Thursday of every quarter at 5:30 p.m.,
- Housing Commission – Every first Wednesday at 6:30 p.m.
- Library Commission – Every third Monday at 6:30 p.m.
- Parks and Recreation Commission – Every fourth Wednesday at 6:30 p.m.
- Planning Commission – Twice a month on a Monday at 7 p.m.

Each commission/committee may establish other operational policies subject to the approval of the City Council. Any changes to the established policies and procedures shall be subject to the approval of the City Council.

5. *Off-premises meeting participation*

While technology allows commission/committee members to participate in meetings from a location other than the meeting location (referred to as “off-premises”), off-premises participation is discouraged given the logistics required to ensure compliance with the Brown Act and experience with technological failures disrupting the meeting. In the event that a commission/committee member believes that their participation is essential to a meeting, the following shall apply:

- Any commission/committee member intending to participate from an off-premise location shall inform the staff liaison at least two weeks in advance of the meeting.
- The off-premise location must be identified in the notice and agenda of the meeting.
- Agendas must be posted at the off-premise location.
- The off-premise location must be accessible to the public and be ADA compliant.
- The commission/committee member participating at a duly noticed off-premises location does not count toward the quorum necessary to convene a meeting of the commission/committee.
- For any one meeting, no more than one commission/committee member may participate from an off-premise location.
- All votes must be by roll call.

6. *Selection of chair and vice chair*

- The chair and vice chair shall be selected in May of each year by a majority of the members and shall serve for one year or until their successors are selected.
- Each commission/committee shall annually rotate its chair and vice chair.

G. Memberships

Appointments/Oaths

- The City Council is the appointing body for all commissions/committees. All members serve at the pleasure of the City Council for designated terms.
- All appointments and reappointments shall be made at a regularly scheduled City Council meeting, and require an affirmative vote of not less than a majority of the City Council present.
- Before taking office, all members must complete an Oath of Allegiance required by Article XX, §3, of the Constitution of the State of California. All oaths are administered by the city clerk or their designee.
- Appointments made during the middle of the term are for the unexpired portion of that term.

Application and selection process

- The application process begins when a vacancy occurs due to term expiration, resignation, removal or death of a member.
- The application period will normally run for a period of four weeks from the date the vacancy occurs. If there is more than one concurrent vacancy in a Commission, the application period may be extended. Applications are available from the city clerk's office and on the City's website.
- The city clerk shall notify members whose terms are about to expire whether or not they would be eligible for reappointment. If reappointment is sought, an updated application will be required.
- Applicants are required to complete and return the application form for each commission/committee they desire to serve on, along with any additional information they would like to transmit, by the established deadline. Applications sent by email are accepted.
- After the deadline of receipt of applications, the city clerk shall schedule the matter at the next available regular City Council meeting. All applications received will be submitted and made a part of the City Council agenda packet for their review and consideration. If there are no applications received by the deadline, the city clerk will extend the application period for an indefinite period of time until sufficient applications are received.
- Upon review of the applications received, the City Council reserves the right to schedule or waive interviews, or to extend the application process in the event insufficient applications are received. In either case, the city clerk will provide notification to the applicants of the decision of the City Council.
- If an interview is requested, the date and time will be designated by the City Council. Interviews are open to the public.
- The selection/appointment process by the City Council shall be conducted at a City Council meeting. The city clerk will ask each City Councilmember for their nominations; the number of nominations is limited to the number of vacancies. The candidate that receives a majority of nominations will be appointed. If there is a tie, multiple rounds of voting will occur.
- Following a City Council appointment, the city clerk shall notify successful and unsuccessful applicants accordingly, in writing. Appointees will receive copies of the City's Non-Discrimination and Sexual Harassment policies, and disclosure statements for those members who are required to file under State law as designated in the City's Conflict of Interest Code. Copies of the notification will also be distributed to support staff and the commission/committee chair.
- An orientation will be scheduled by the city clerk following an appointment (but before taking office) and a copy of this policy document will be provided at that time.

Attendance

- A compilation of attendance will be submitted to the City Council at least annually listing absences for all commissions/committee members.
- Absences, which result in attendance at less than two-thirds of their meetings during the calendar year, will be reported to the City Council and may result in replacement of the member by the City Council.
- Any member who feels that unique circumstances have led to numerous absences can appeal directly to the City Council for a waiver of this policy or to obtain a leave of absence.
- While it is expected that members be present at all meetings, the chair and staff liaison should be notified if a member knows in advance that they will be absent.

- When reviewing commissioners for reappointment, overall attendance at full commission meetings will be given significant consideration.

Compensation

- Members shall serve without compensation (unless specifically provided) for their services, provided, however, members shall receive reimbursement for necessary travel expenses and other expenses incurred on official duty when such expenditures have been authorized by the City Council (See Policy CC-19-002).

Conflict of interest and disclosure requirements

- A Conflict of Interest Code has been updated and adopted by the City pursuant to Government Code §87300 et seq. Copies of the conflict of interest code are filed with the city clerk. Pursuant to the adopted Conflict of Interest Code, members serving on the Complete Streets Commission, Housing Commission, and Planning Commission are required to file a Statement of Economic Interest with the city clerk to disclose personal interest in investments, real property and income. This is done within 30 days of appointment and annually thereafter. A statement is also required within 30 days after leaving office.
- If a public official has a conflict of interest, the Political Reform Act may require the official to disqualify themselves from making or participating in a governmental decision, or using their official position to influence a governmental decision. Questions in this regard may be directed to the city attorney.

Qualifications, compositions, number

- In most cases, members shall be residents of the City of Menlo Park and at least 18 years of age.
- Current members of any other City commission/committee are disqualified for membership, unless the regulations for that advisory body permit concurrent membership. Commission/Committee members are strongly advised to serve out the entirety of the term of their current appointment before seeking appointment on another commission/committee.
- Commission/Committee members shall be permitted to retain membership while seeking any elective office. However, members shall not use the meetings, functions or activities of such bodies for purposes of campaigning for elective office.
- There shall be seven (7) members on each commission/committee.

Reappointments, resignations, removals

- Incumbents seeking a reappointment are required to complete and file an application with the city clerk by the application deadline. No person shall be reappointed to a commission/committee who has served on that same body for two consecutive terms; unless a period of one year has lapsed since the returning member last served on that commission/committee (the one-year period is flexible subject to City Council's discretion).
- Resignations must be submitted in writing to the city clerk, who will distribute copies to City Council and appropriate staff.
- The City Council may remove a member by a majority vote of the City Council without cause, notice or hearing.

Term of office

- Unless specified otherwise, the term of office for all commission/committees shall be four (4) years unless a resignation or a removal has taken place.
- If a person is appointed to fill an unexpired term and serves less than two years, that time will not be considered a full term. However, if a person is appointed to fill an unexpired term and serves two years or more, that time will be considered a full term.
- Terms are staggered to be overlapping four-year terms, so that all terms do not expire in any one year.
- If a member resigns before the end of their term, a replacement serves out the remainder of that term.

Vacancies

- Vacancies are created due to term expirations, resignations, removals or death.
- Vacancies are posted by the city clerk in the City Council Chambers bulletin board and on the city website.
- Whenever an unscheduled vacancy occurs in any commission/committee, a special vacancy notice shall be posted within 20 days after the vacancy occurs. Appointment shall not be made for at least 10 working days after posting of the notice (Government Code §54974).
- On or before December 31 of each year, an appointment list of all regular advisory commissions/committees of the City Council shall be prepared by the city clerk and posted in the City Council Chambers bulletin board and

on the City's website. This list is also available to the public (Government Code §54972, Maddy Act).

Roles and Responsibilities

Complete Streets Commission

The Complete Streets Commission is charged primarily with advising the City Council on realizing the City's adopted goals for complete streets, vision zero, climate action plan, and provide input on major land use and development projects as it relates to transportation. The Complete Streets Commission's responsibilities include:

- To advance the goals of the city's newly adopted climate action plan by making alternatives to driving safer and more attractive
- Advise City Council on the implementation of the transportation master plan.
- Continue to advocate for and advise the City Council on planning and installing pedestrian and bicycle rail crossing and safe cycling/pedestrian infrastructure.
- Continue to support City Council in ongoing initiatives to improve access to Downtown and support downtown businesses.
- Continue to support the implementation of the Safe Routes to School strategy and advocate for community engagement, program continuity and engineering implementation.
- Continue to support City Council's role as a stakeholder with regard to regional multi-modal and transportation demand management programs projects to increase

The Environmental Quality Commission is committed to helping the City of Menlo Park to be a leading sustainable city that inspires institutions and individuals and that is well positioned to manage present and future environmental impacts, including the grave threat of climate change. The Environmental Quality Commission is charged primarily with advising the City Council on matters involving climate change, environmental protection, and sustainability.. Specific focus areas include:

- Climate Action Plan - Advise and recommend on the implementation of the climate action plan.
- Climate Resilience and Adaptation - Ensure that our most vulnerable communities have a voice in policies and programs to protect their communities from environmental impacts.
- Urban Canopy - Leverage best practices to advise/recommend on the preservation of heritage trees, city trees and expansion of the urban canopy; and make determinations on appeals of heritage tree removal permits.
- Green and Sustainable Initiatives – Support sustainability initiatives, as needs arise, which may include city-led events, habitat protection, healthy ecology, environmental health protection, healthy air, surface water runoff quality, water conservation and waste reduction.

Finance and Audit Commission

The Finance and Audit Commission is charged primarily to support delivery of timely, clear and comprehensive reporting of the City's fiscal status to the community at large. Specific focus areas include:

- Review the process for periodic financial reporting to the City Council and the public, as needed
- Review financial audit and annual financial report with the City's external auditors
- Review of the resolution of prior year audit findings
- Review of the auditor selection process and scope, as needed

Housing Commission

The Housing Commission is charged primarily with advising the City Council on housing matters including housing supply and housing related problems. Specific focus areas include:

- Community attitudes about housing (range, distribution, racial, social-economic problems)
- Programs for evaluating, maintaining, and upgrading the distribution and quality of housing stock in the City
- Planning, implementing and evaluating City programs under the Housing and Community Development Act of 1974
- Review and recommend to the City Council regarding the Below Market Rate (BMR) program
- Initiate, review and recommend on housing policies and programs for the City
- Review and recommend on housing related impacts for environmental impact reports
- Review and recommend on State and regional housing issues
- Review and recommend on the Housing Element of the General Plan

Library Commission

The Library Commission is charged primarily with advising the City Council on matters related to the maintenance and operation of the City's libraries and library systems. Specific focus areas include:

- The scope and degree of library activities
- Maintenance and protection of City libraries
- Evaluation and improvement of library service
- Acquisition of library materials
- Coordination with other library systems and long range planning
- Literacy and ESL programs

Parks and Recreation Commission

The Parks and Recreation Commission is charged primarily with advising the City Council on matters related to City programs and facilities dedicated to recreation. Specific focus areas include:

- Those programs and facilities established primarily for the participation of and/or use by residents of the City, including adequacy and maintenance of such facilities as parks and playgrounds, recreation buildings, facilities and equipment
- Adequacy, operation and staffing of recreation programs
- Modification of existing programs and facilities to meet developing community needs
- Long range planning and regional coordination concerning park and recreational facilities

Planning Commission

The Planning Commission is organized according to State Statute.

- The Planning Commission reviews development proposals on public and private lands for compliance with the General Plan and Zoning Ordinance.
- The Commission reviews all development proposals requiring a use permit, architectural control, variance, minor subdivision and environmental review associated with these projects. The Commission is the final decision-making body for these applications, unless appealed to the City Council.
- The Commission serves as a recommending body to the City Council for major subdivisions, rezoning's, conditional development permits, Zoning Ordinance amendments, General Plan amendments and the environmental reviews and Below Market Rate (BMR) Housing Agreements associated with those projects.
- The Commission works on special projects as assigned by the City Council.

Special Advisory Bodies

The City Council has the authority to create standing committees, task forces or subcommittees for the City, and from time to time, the City Council may appoint members to these groups. The number of persons and the individual appointee serving on each group may be changed at any time by the City Council. There are no designated terms for members of these groups; members are appointed by and serve at the pleasure of the City Council.

Any requests of city commissions or committees to create such ad hoc advisory bodies shall be submitted in writing to the city clerk for City Council consideration and approval.

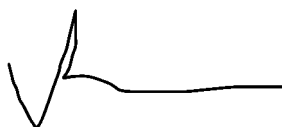

Education

Please note that the following is the same application that I previously used to apply for Menlo Park's EPA Sanitary District oversight committee position (at the recommendation of Mayor Drew Combs), and that most of the points made in it would be still be highly relevant if I were to become a member on the Environmental Quality Commission. Also, I would appreciate it if the Menlo Park City Council took the time to actually review my application this time around (as this did not seem to have been the case when I originally applied for the EPASD position).

Born at Stanford Children's Hospital and raised in Menlo Park, I had an unique upbringing as both a world-class, adventure-sport athlete (mountain-climbing, sailing, skiing & scuba diving) and an academically accelerated student (being accepted to a university at age 10 and graduating at UC Berkeley (neuroscience, after taking 2 years off in the middle to solo-sail competitively with Team USA globally while travelling to some 75 countries) by age 16, where I learned to appreciate the environment and California's outdoors. Between 16 and 18 I won three of the Bay Area's best startup competition for all-comers (not just students) in blockchain technology and received venture funding which I set aside to spend a year turning around a medical device company that was critical to covid recovery in the ER where I also led the successful design and miniaturization and FDA approval of the first ever EEG headset for tiny preemie babies. After gaining entry at 18 as the youngest ever in history to enter an MBA program (via an age waiver by about 10 years) at age 19 I became the youngest ever to complete an earned (non-research) masters at near enough the oldest college (St. Johns) at near enough the oldest university (Oxford, UK) in the world. Save for some business experience in the past year or two since the MBA my twin brother had identical accomplishments until he joined Boston Consulting Group (BCG, the rival of McKinsey) as the youngest ever hire by 10 years and now after promotion is on track to be a partner by age 26 – typically one makes partner at 40 to 45 – at their no. 1 global office, San Francisco.

I on the other hand, have declined similar opportunities, and given my interest in technology taken a more entrepreneurial path a tech and have worked in raising venture funds and new business development in 4

startups in neuro-medicine, cybersecurity, sports/events ticketing platforms and most pertinently to the current application to EPASD, in novel, cheap electrolytic technology to recycle and reuse the worst sewage water (pit latrines to septic tanks) including for drinking purposes in rural and urban areas in third world countries where there are no public sewers and water has become scarce. Additionally, with direct relevance to my application here, together with my ex-Stanford Professor Dad who has previously built, developed and sold 100s of homes and retail shops in 3 countries (Singapore, USA and India) we have recently bought, next door to our 25 year home, 6 EPASD district Menlo Park homes on 2 lots of about an acre total and are in the permitting process to redevelop them into more affordable 11 homes.

The above being a general overview, I provide additional details below.

From an early age, I spent many seasons in the Sierra Nevada's, learning to ski by age 2 and hike tall mountains by age 3-4 when I climbed up & down 11,000 ft over three days through 33 miles of Yosemite's Grand Canyon of the Tuolumne near & along the Hetch Hetchy Reservoir – the primary fresh water source for over half of the San Francisco Bay Area. By age 6, I was the youngest to climb Mt. Whitney (14,000 ft.) - the tallest mountain in the continental USA, and by age 7, became the youngest to ever climb Mt. Kilimanjaro - the tallest mountain in Africa, as well as the youngest to climb up to 20,000 feet in history (receiving commendation by President Bill Clinton). By age 8, I was a national-level skier before switching to solo sailing, and by age 10 became the best youth sailor west of Mississippi River (western half of USA) and one of the youngest to ever become scuba-certified (recently achieving PADI Rescue Diver status).

Academically, with high ACT and AP scores, I was accepted to UC Berkeley at age 10, becoming the youngest student to ever be accepted to college. There, I majored in Molecular & Cellular Neurobiology and graduated by age 16 near the top of my class. In addition to extensive training in both biology, chemistry and physics theory and experimentation, I also conducted publishable computational biology research on protein folding & evolution in Berkeley HHMI investigator Prof. Michael Eisen's lab (who unsuccessfully ran for California Senator Dianne Feinstein's seat in 2018 to restore non-partisanship towards and public confidence in the role of science in policy making) and practiced graduate-level CRISPR-Cas9/genetic editing techniques in Nobel Laureate Jennifer Doudna's lab.

Additionally, in my final semester at Berkeley, I led my team to 1st place in a series of prestigious entrepreneurship challenge competitions and startup accelerators against hundreds of Stanford and Berkeley computer science students, MBAs and professors. Gaining the support of senior, mostly C-suite, executives at Oracle, Wells Fargo and Intuit, I raised \$500K in seed funding to develop blockchain technology to enable estate planning and auto-execute wills and trusts (although this was put on hold due to key team members contracting COVID).

Undeterred, I soon joined a neuro-medtech device manufacturing & research startup that sells its novel, miniaturized EEG-recording/brain-monitoring systems (hardware, wearable recording device, software, and chemicals that are 10X smaller and cheaper than existing, legacy platforms) to 300 hospitals across the US. Upon joining as an intern and with the company on the verge of bankruptcy, I assisted the new management in their successful multi-year turnaround. Initially, I recreated two years of accounts previously mismanaged by a fired bookkeeper, recovered unbilled, uncollected revenue & eliminated unnecessary expenses totaling >\$50k and corrected financial statements that misled investors and cost them millions of dollars eventually being promoted to Controller/Assistant CFO. Upon reaching profitability, we turned our attention to the underlying processes and technology. First, I helped streamline the company's organizational structure and improve employee training. Second, I assisted in overhauling FDA compliance, updating thousands of pages admin, safety, compliance, testing, quality,

and manufacturing procedures in a 24/7, 3-month on-site marathon effort to avoid shut down after years of failed inspections and an FDA-mandated recall due to sub-supplier contamination. Third, I reorganized intellectual property to support new R&D, managing tens of patents & trademarks and collated the findings from 30 different research projects undertaken over almost two decades. Fourth, I introduced new, cost-saving manufacturing equipment and project-managed the design, development and FDA clinical trialing of the first-ever, disposable, infant EEG-recording headset (likely needed by 1 in 10 births nationwide) to improve monitoring and outcomes for neonates in the ICU, successfully leading a team of three – with support from Harvard Medical School researchers who encouraged the project – through the pandemic.

On the side, I also spent several months in manual construction to assist in and manage the remodel of multiple houses in the Willows, working with minimum-wage handymen to lift 80 lb.-cement bags; paint fences/houses; fix sprinkler systems & sewers/plumbing; build decks; lay flooring, roofing & patios; landscape, plant 100+ plants (bamboo, fruit, maple, lavender & tulips), cut/prune (large) trees, install gutters & electricals, and replace 50 ft of plumbing lines.

Interested in pursuing further research utilizing these technologies, I attended University of Oxford to investigate neurodevelopment, improve neonatal surgery and develop AI-detection algorithms for sports concussions and Autism. While in England, I also gained an MBA from Oxford's Said Business School (SBS) as the youngest MBA student (accepted at age 18, graduated at 20) in the history of MBAs. During my studies, I also led the Oxford rocketry club build and launched test rockets with the UK Space Agency in their development of Europe's first rocket launch facility in the Scottish isles near the Arctic Circle.

Returning to the United States, my primary focus has been towards fundraising and scaling leading various water recycling and cybersecurity startups. The first is a startup whose mission is to sustainably recycle wastewater into drinking water in infrastructure-poor, developing regions with a plug-and-play, infrastructure-as-a-service business model leveraging its proprietary, world-leading titanium chemistry technology. The unit itself is easily movable, being the size of a small shipping container and thus obviating the need for expensive, infrastructure-intensive, industrial-sized sewage treatment facilities and networks of pipes. Instead, the unit electrolytically treats the sewage on the spot and generates fresh, drinking water for immediate reuse or to be pumped into the ground to recharge the stressed and often depleted groundwater tables/aquifers - all at a cost of just a several cents per gallon.

Recently, the water-recycling company has secured contracts to treat and recycle to drinking water quality the sewage & wastewater of hundreds of hotels owned by major, Western brands in India, Thailand and the Middle East. Flexible in application, the units have also been used to process palm oil effluent of the world's leading producers in Malaysia & Indonesia as well as biomedical wastewater by the United Nations in their refugee camps in Nepal and the ongoing Israel-Gaza war/humanitarian crisis. In addition to reducing pollution in globally critical rainforests and improving public health by eliminating waterborne diseases such as diarrhea and dysentery that are leading causes of illness and death, the unit's energy efficiency (requiring only electricity) greatly reduces carbon emissions particularly in places where people currently rely on cutting down trees to gain firewood to boil water every day.

Regarding cybersecurity, I am currently involved with three companies – the current world leader in brand protection, cyberfraud/fake products and phishing company whose customers include ~300 companies (incl. OpenAI), Britain's oldest cybersecurity consulting firm that advises the UK's largest companies, hospitals, energy producers and sewage management firms, and a fast-growing startup that specializes in quantum-proof encryption to address data privacy.

Sports:

At age 12, I also took two years off from my university studies to focus full-time on my sailing career where I represented Team USA twelve times internationally, eventually reaching the top 2 in my age group nationally and top 10 internationally in the under-15 class. I then spent the next several years sailing high-performance, foiling catamarans (sailing boats similar to those used in the America's Cup) as a member of the US Olympic Development team with many coaches and teammates competing at the 2024 Paris Olympics. Through these experiences, I was able to travel to all 50 US states, 2 of the 4 US Protectorates/Territories, and over 75 countries across 5 continents (staying at least a few days in each, and weeks in dozens of them), including visiting hundreds of world-class museums and staying with hunter-gatherer 'bushmen' deep in Africa.

Civic Participation & Elections

When I was 8-10 years old, I door-knocked on 4,000 houses for several local Menlo Park, California city elections and distributed flyers & encouraged voting in a non-partisan, regardless of political affiliation to improve voter turnout. In fact, on a few occasions, my twin brother and I faced hostility from a handful of residents even in Menlo Park – a harbinger of politics today. While at Oxford, I also assisted a fellow MBA classmate and MP candidate (as his Chief of Staff) to successfully navigate municipal elections, the intra-party vetting process and eventually campaign for Parliament despite the chaos of Brexit and COVID.

Public Health:

I was a Covid-19 Tester & Lab Tech in the first, US Covid Seroprevalence study conducted by Stanford Medical School and the local San Mateo & Santa Clara Counties. I participated in many different roles, from testing patients to organizing & streamlining the whole process onsite, greatly improving efficiency & safety. Although highly controversial, the study results were featured in the NY Times, Washington Post, CNN etc., and advised White House Covid Policy, with volunteers like me receiving acknowledgments in the final paper. (One of the Stanford professors who authored the effort has been recently selected to become the next Director of the NIH (and responsible for all government-funded medical research) as one of the incoming Trump Administration's least controversial picks – go figure. :)

With my twin, I personally funded a charitable expansion of the neuromedtech company's prior Cerebral Malaria research that is becoming the new WHO standard-of-care & has the potential to reduce global childhood mortality by 8%. Using cheaper equipment, generic drugs, EEG software & telemedicine, we were able to cut costs from \$10K to just \$10 per life saved and held discussions with Health Ministers in Africa & South America and major NGOs like the Gates Foundation.

Scouting & Community Service:

From ages 5-12, I was heavily involved with the local Cub (finished program 2 years early with almost all possible badges earned) and Boy Scout (achieved rank of 1st class within 2 years before focusing on sailing) programs. As a Scout, I participated in and helped lead 20-30 charitable outings including flag planting at the Golden Gate National Cemetery every Memorial Day (where we each hand-planted American flags in front of hundreds of headstones to honor fallen veterans), building tens of play structures for Habitat for Humanity, 2nd Harvest Food Bank's canned food drives, collecting trash at Yosemite and Kings Canyon National Parks, and assisting and Xmas caroling for the elderly at local senior living homes. I subsequently was part of the 50-student MA student council team that collected one of America's largest high-school-run canned food drives collecting 250,000+ lbs.

Played Saxophone for 6+ years in Oak Knoll Elementary, Hillview Middle

and Menlo-Atherton (MA) High School concert/marching/pep bands and choir, performing in multiple annual Menlo Park downtown Halloween parades and seasons of pep band & half-time entertainment for home MA football games. Also performed 3x with MA's state-ranked concert/jazz band at Disneyland.

Describe your understanding of the responsibilities of each advisory body you are applying to and how your personal community or professional experience relate to these responsibilities

Again, while the following was written with the EPASD position in mind, the arguments made below would reflect my general interests and abilities in serving on the Environmental Quality Commission:

Given my wide-ranging experiences and accomplishments, I would be able to serve as an advisory board member to support and promote the following:

- Provide firm oversight into the new, consolidated water district on behalf of Menlo Park residents. Given my experience in helping turn around mismanaged startup companies where I helped investors and management eliminate tens of thousands of dollars in wasteful spending and uncollected revenues (as Controller/CFO), identify millions of dollars in unaccounted-for-losses (as Bookkeeper), and successfully assist creditors in recouping millions lost in fraud (part of which I self-represented without a lawyer in court), I would be well-equipped to spot & prevent frivolous & illicit spending in the future.
- Given my studies and varied experiences in chemistry, biology, medical technology & manufacturing, FDA regulation, public health, and water-recycling/wastewater management, I would bring relevant, subject matter expertise and a tech-approach to the advisory body representative of tech entrepreneurship that Silicon Valley is known for.
- Support innovation with a focus on climate change, public health and cybersecurity. Simply maintaining dated infrastructure systems is unlikely to be enough to address these critical issues. New ideas and approaches will be needed to address questions like:
 - o How can we reduce our carbon footprint, conserve water in the face of growing droughts, and promote climate resiliency? My experiences with low cost, low emissions and low infrastructure spend water purification technology in Asia, the Middle East and Africa would enable me to investigate new ways of playing our part against climate change. And as a longtime sailor on the San Francisco Bay (including in our nearby Bair Island and Ravenswood wetlands) and neighbor within 2 blocks of the away the already flood-prone San Francisquito Creek, I would provide a local perspective on flooding and sea-level rise.
 - o One of the most effective ways public health officials could track the pandemic was by measuring COVID levels in sewage systems. What other ways could we leverage our sewage system to better inform us about future pandemics? Additionally, as more biotech laboratories are being constructed in the Bay Area, what additional safeguards are being implemented to ensure that biowaste or pathogens generated by these labs are being properly treated?
 - o Cyber-attacks are only becoming more damaging and frequent with the rise of AI and greater geopolitical tension, and aging infrastructure, often overlooked, that provide basic services are the often the weakest links. 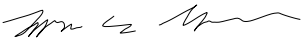
