








# CONGESTION ANALYSIS (PM PEAK DIVERTED TRIPS)

#### Recommendation

Staff recommends that the Complete Streets Commission adopt Resolution No. 2021-5 (Attachment A) to approve the removal of five parallel on-street parking spaces, two on the left side, three on the right side of the existing driveway at the 2225 Sharon Road apartment complex (Project). The purpose of this work is to improve the existing line of sight for drivers exiting the driveway.

#### **Policy Issues**

Section 11.24.026 of the City Municipal Code authorizes the Complete Streets Commission to designate "No Parking Zone" (i.e., red curb) adjacent to driveways, intersections, and crosswalks under specific criteria for safety concerns.

This Project is also consistent with the policies and programs (i.e., CIRC-1.1, CIR-4.4) stated in the 2016 General Plan Circulation Element. These policies and programs seek to maintain and improve a circulation system through the Street Classification System that provides safe and efficient movement of people and goods throughout Menlo Park for residential and commercial purposes.

#### **Background**

In June, a resident from the 2225 Sharon Road apartment complex contacted the City and explained that on street parking near the driveway creates difficulties for drivers to make either left turns or right turns onto Sharon road safely due to inadequate sight distance.

Currently, there are 15 feet of red curb on the left, and 17 feet of red curb on the right of the driveway. The site is adjacent to Entrada Middle School and multi-family developments. As a result, larger vehicles often park near the driveway. Additionally, the driveway is located at the end of a curve, leading to limited line of sight for vehicles exiting the driveway and vehicles approaching from either direction on Sharon Road.

Sharon Road has a posted speed of 25 miles per hour (mph). According to the American Association of State Highway and Transportation Officials' (AASHTO) Policy on Geometric Design of Highway and Streets,155 feet of stopping sight distance is required for 25 mph roadways.

#### **Analysis**

Base on a field investigation, the current driveway line of sight is below the minimum 155 feet, when vehicles are parked next to the driveway. To have a clear view of approaching vehicles, drivers exiting the

driveway must cross the stop bar, and encroach into the roadway before proceeding.

To achieve 155 feet stopping sight distance, a total of 77 feet of red curb is needed to create an unobstructed view from the right edge of the driveway. Currently, there is 17 feet of existing red curb. Therefore, another 60 feet of red curb will be needed, or the equivalent of approximately three parking spaces.

On the left side, 30 feet of additional red curb is needed to supplement the 15 feet of existing red curb, for a total of 45 feet, to provide the 155 feet required stopping sight distance, or the equivalent of approximately two parking spaces.

Attachment B illustrates the proposed Project.

#### Next steps

Per Section 11.24.028 of the Municipal Code, if the Project is approved, any Menlo Park resident, business owner, or property owner may appeal to the City Council in writing within fifteen (15) days after the decision, by November 25, 2021.

#### **Impact on City Resources**

If approved, the Project will be implemented through the City's signing and striping program.

#### **Environmental Review**

The installation of red curb is categorically exempt under Class 1 of the California Environmental Quality Act. Class 1 allows for minor alterations of existing facilities, including highways and streets, sidewalks, gutters, bicycle and pedestrian access, and similar facilities, as long as there is negligible or no expansion of use.

#### **Public Notice**

Public Notification was achieved by posting the agenda, with the agenda items being listed, at least 72 hours prior to the meeting. Additional public outreach was achieved by sending notification postcards to the residents/property owners within 500 feet of the proposed "No Parking Zone". In addition, posters with the Project and meeting information were placed on A-frames at the site.

RESOLUTION OF THE COMPLETE STREETS COMMISSION OF THE CITY OF MENLO PARK AUTHORIZING THE INSTALLATION OF NO PARKING ZONES ON SHARON ROAD FRONTING 2225 SHARON ROAD

WHEREAS, the City of Menlo Park received a resident request to evaluate inadequate driveway sight distance issue at the 2225 Sharon Road apartment complex; and,

WHEREAS, a field investigation revealed limited sight distance due to vehicles park next to the 2225 Sharon Road driveway; and,

WHEREAS, the driveway is located at the end of a curve; and,

WHEREAS, extending the existing red curb zones adjacent to the 2225 Sharon Road driveway (i.e., 60 feet of new red curb with 17 feet of existing red curb for a total of 77 feet to the right, 30 feet of new red curb with 15 feet of existing red curb for a total of 45 feet to the left) is needed to achieve 155 feet stopping sight distance; and,

WHEREAS, Section 11.24.026 of the Menlo Park Municipal Code authorizes the Complete Streets Commission to designate no parking zones as described in the Municipal Code; and

WHEREAS, the City of Menlo Park, acting by and through its Complete Streets Commission, having considered and been fully advised in the matter and good cause appearing therefore; and

NOW, THEREFORE, BE IT RESOLVED, that the Complete Streets Commission of the City of Menlo Park does hereby authorize the installation of red curb zones on Sharon Road fronting 2225 Sharon Road.



#### Recommendation

Staff recommends that the Complete Streets Commission adopt Resolution No. 2021-6 (Attachment A) supporting the City's application for a City/County Association Governments (C/CAG) of San Mateo County Transportation Development Act (TDA) Article 3 Grant for a pedestrian and bicycle crossing improvement at Van Buren Road and Ringwood Avenue, a necessary condition for the City to apply for this funding.

#### **Policy Issues**

The City's General Plan Circulation Element identifies Ringwood Avenue as a bikeway, providing a connection to the pedestrian and bicycle overcrossing over US 101.

Section 11.12.010 of the Menlo Park Municipal Code authorizes the City Council to order the installation, use, change or removal of traffic control devices, including marking crosswalks and other crossing improvements.

#### Background

C/CAG is responsible for administering the TDA Article 3 Program in San Mateo County. The program is intended to fund eligible pedestrian and bicycle projects. C/CAG has \$2,250,000 available across the County in the Fiscal Year 2022-2023 cycle, including \$1,950,000 for capital projects and \$300,000 for comprehensive bicycle and/or pedestrian plans.

Eligible capital projects include:

- Construction of a bicycle or pedestrian capital project (Plans, Specifications &Engineering (PS&E) and construction phases only)
- Quick Build bicycle and pedestrian projects
- Restriping bicycle lanes
- Maintenance of a multi-purpose path, which is closed to motorized traffic

The application requires the applicant to have a Bicycle and Pedestrian Advisory Committee or similar body that is appointed by the City Council. The Complete Streets Commission (CSC) advises the City of Menlo Park on transportation matters including bicycle and pedestrian planning and design issues. A formal resolution or letter of support is required from the CSC.

#### **Analysis**

The City is planning to apply for a grant to improve the intersection of Van Buren Road and Ringwood Avenue, at the location of the pedestrian and bicycle crossing over US 101. A proposed improvement was identified at this location (Attachment B) as part of the Belle Haven Traffic Calming Plan (BHTCP) that was approved by City Council on September 21, 2021. Because the improvement was outside of the Belle Haven neighborhood and not impacted directly by the potential cut-through traffic from development in the Bayfront area that led to the development of the BHTCP, it was not possible to fund the project using that source.

The proposed improvement involves extending the path adjacent to US 101 (partially in the Caltrans right of way) and constructing a raised crosswalk across Van Buren Road. The path is partially in Caltrans right of way and will require some coordination. This improvement will address a crossing with a history of vehicle/bicycle collisions. Staff have selected this project as a small, but meaningful improvement in the safety of an important east-west travel route through the City. Bicyclists traveling east-west in Menlo Park must traverse a number of significant barriers that add discomfort and stress to their travel, including Bayfront Expressway, the Dumbarton Rail corridor, US 101, the Caltrain rail corridor, and El Camino Real.

Both Menlo Park and the County have identified the need for bikeway improvements on major routes, including both Marsh Road and Willow Road/State Route 114, but achieving low stress facilities on these routes will require significant investment. This route provides an alternate route through the neighborhoods between Marsh Road and Willow Road that includes bikeways crossing each of the major barriers. The proposed project addresses a safety concern along this corridor.

The project was also selected for its project readiness. TDA Article 3 funds can only be used for PS&E and construction phases of work, and require planning phases to be complete. The proposed improvement has received concept design and cost estimation as part of the BHTCP that enables the City to put in an application for the project. No other project is at the same level of readiness for this funding source at this time.

Applications are due to C/CAG on November 15, 2021 and will be scored by the C/CAG BPAC in February. Formal approval is expected in Spring 2022. If the application is selected, the City anticipates that final design would be completed before the end of 2022 and construction would occur in 2023.

#### **Impact on City Resources**

The TDA Article 3 Grant requires a 10 percent match from City funds. City staff anticipate this funding would be drawn from the Transportation Minor budget item.

#### **Environmental Review**

Environmental review is categorically exempt under Class I (Existing Facilities) of the California Environmental Quality Act since it involves minor construction on a public street. No additional vehicle miles traveled or roadway capacity will be added by this project.

#### **Public Notice**

Public notification was achieved by posting the agenda, with the agenda items being listed, at least 72 hours prior to the meeting. Additional public outreach will be conducted in advance of finalize the project design and again in conjunction with construction.
