

Campus parking management plan

Recommendation

Staff recommends the Complete Streets Commission provide feedback on recommendations developed for the Menlo Park Community Campus (MPCC) parking management plan (Plan).

Policy Issues

City Council established the MPCC project as one of the City's top priorities.

The development of a parking management plan is consistent with policies and programs (i.e., CIRC-7.2, CIR-7.4) stated in the 2016 General Plan Circulation Element. These policies and programs seek to ensure properly designed and efficiently used off-street parking facilities.

Background

On December 16, 2019, META (formerly Facebook) submitted its proposal to develop a new multigenerational center at 100-110 Terminal Avenue to incorporate the former Onetta Harris Community Center, Menlo Park Senior Center, Belle Haven Youth Center (childcare), Belle Haven Pool and branch library. The new branch library is intended to replace the existing Belle Haven Branch Library located within the Belle Haven Elementary School.

The City Council approved the MPCC project on January 12, 2021, and the pool design on February 1, 2021. The new 37,080 square foot (s.f.) building will replace the former 34,080 s.f. community center.

Construction began in November 2021 and is tentatively set to open in 2024. Attachment A illustrates the proposed site plan including the MPCC project, Beechwood School, and Kelly Park (Site).

Shared parking analysis

In late 2020, META retained a transportation consultant (Fehr & Peers) and conducted a shared parking analysis based on the existing and future land uses within the Site. For the purpose of this discussion, the Site is divided into two community areas: 1) MPCC plus Beechwood School, and 2) Kelly Park.

Given the various components of the Site generate parking demand that peak at different times of the day and the additional demand of a new branch library, the consultant worked with City staff and developed parking demand assumptions under existing and future conditions. In general, the parking supply provided for each community area is insufficient to accommodate their respective peak hour demands. However, given the non-competing demands from these two community areas, the total supply would be sufficient if combined

While it may be less convenient to park and walk to opposite sides of the Site, considering both areas together allows purposeful community space to be maximized over additional parking spaces. Further, staff has evaluated the operational needs of the various site components to work towards minimizing the impact on site users (i.e., ensuring accommodation for Beechwood School, childcare pick up and senior parking). Table 1 summarizes the findings.

While the future parking supply is expected to accommodate typical weekday/weekend demand, the analysis did not evaluate the demand of special large events that are typically held only a few times a year. Based on previous observations, staff acknowledge that some of these special large event may have parking demands that exceed capacity. Staff will continue to collect feedback and explore strategies to reduce parking demand.

A hyperlink to the December 14, 2020 Planning Commission staff report that includes the comprehensive shared parking analysis is included as Attachment B.

Site plan

In early 2022, the City reviewed and requested additional pedestrian circulation improvements boarding the MPCC building frontage (i.e., converted a standard crosswalk to a raised crosswalk), which reduced the total future parking supply from 164 to 162 parking spaces.

Potential stop sign at Terminal Avenue and Del Norte Avenue

In response to resident requests, on October 18, 2022, the City Council approved a number of intersections citywide to receive new stop signs, including the intersection of Terminal Avenue and Del Norte Avenue.

Currently, vehicles passing through the intersection are stop-controlled on Del Norte Avenue and free flowing on Terminal Avenue. With new stop signs on Terminal Avenue, it will become an all-way stop intersection.

Analysis

The new MPCC will incorporate space for facilities and services previously located on-site. As a result, parking demand is likely to remain similar for each of the existing uses (e.g., community center, youth center, pool, Beechwood School, etc). Staff recognize discussions about community programming and facility operating hours are still ongoing and could influence future parking needs. As a result, staff will continue to explore and emphasize transportation demand management programs through these discussions to minimum parking demand.

While the addition of a relocated branch library was captured in the shared parking analysis, staff has identified additional components that could influence existing/ future parking and circulation demands.

Pick up/drop off demand

In response to the 2019 pandemic, the City modified the delivery method of two critical community food/meal distribution services to our seniors and families. This change allowed community members to circulate the site without exiting their vehicles to minimize exposure. This delivery method is expected to continue after the MPCC project is completed.

The Youth Center after school programs will continue the practice of parental "sign-out" release. As a result, most vehicles will require short term parking. These activities will likely occur between the hours of 5 p.m. to 6 p.m.

General expansion of activities and operating times at the community center and a national trend towards use of transportation network companies (e.g., Uber/Lyft) may also increase the extent of pick up and drop off behavior. These trends are difficult to estimate before the center has opened and will likely make sense to monitor over time.

Overnight parking

Through community feedback and staff observations, vehicles park overnight at the former community center parking lot and are expected to return after the MPCC project is completed. This demand is partially the result of a City policy (Municipal Code 11.24.050) that prohibits vehicles from stopping/standing/parking on residential zones between 2 a.m. and 5 a.m.

With the MPCC project, the pool and community service operations may open earlier in the morning (e.g., pool service could begin as early as 5 a.m., depending on the contract with the future pool operator).

Feedback

Based on the findings above, staff is requesting feedback from the Commission on the following considerations (illustrated in Attachment C):

- Prioritization of parking for Beechwood School, consistent with past practice
- Installing a small number of time restricted spaces to serve high turnover uses
- Designating priority spaces for seniors
- Converting the MPCC building frontage drive aisle to one-way circulation to serve pick-up and drop-off needs in addition to emergency access
- Exploring adjustments to overnight parking requirements. This would likely require a separate resolution for individual City facilities or an ordinance to address overnight parking needs in parks facilities across the City
- Installing a new all-way stop at Terminal Avenue and Del Norte Avenue
- Any other additional feedback

Next steps

Staff will incorporate Commission feedback into draft recommendations, including any potential ordinance changes or resolutions that would return to a future Complete Streets Commission meeting for recommendation to the City Council.

Impact on City Resources

Any future new signs and striping required by the ultimate recommendations of the Parking Plan will be implemented through the MPCC project.

Environmental Review

On January 12, 2021, the City Council found the MPCC project categorically exempt pursuant to the California Environmental Quality Act (CEQA) Guidelines Section 15302 Replacement of Existing Facilities. The Plan intents to fulfill the vehicular parking needs generated by the MPCC and Kelly Park. On January 21, 2021, staff filed a notice of exemption with the San Mateo County Clerk.

This item is to seek Commission direction and no action is requested. Environmental review of future actions will be assessed when requested.

Public Notice

Public notification was achieved by posting the agenda, with the agenda items being listed, at least 72 hours prior to the meeting. Additional public outreach was achieved by sending notification postcards to the residents/property owners within 500 feet of the MPCC project.


