Bike Rack Survey and Inventory

The Goal

To meet our city-wide goal of reducing Vehicle Miles Traveled by 25% by 2030, we need to make active transport attractive.

As pointed out in the Vision Zero Action plan "Fewer car trips can mean fewer fatal and serious injury collisions."

We are hearing from our community that they need to feel safe on a bike and they need appropriate bike storage (secure, sufficient, and convenient).

The Ask from City Council

- Where are our bike racks?
- Are they working?
 - Do they need replacing or repair?
 - Are they the wrong type? Large enough for cargo bikes?
 - Are they appropriately located, sufficient space, clearly marked, etc.?

Example: At Coffeebar downtown, there is one rack, allowing for two bikes total. Once full, customers locked their bikes up to trees and sign posts instead of the rack located far from businesses.






Overview of the survey




The survey ran during the month of May (Bike Month). Flyers were posted around town with a scannable QR code, and links in Spanish and English were sent through a variety of distribution channels including newsletters, social media, school emails,

council emails, and more.







Type of Bikes

What kind of bike/scooter do people in your household use? Mark all that apply

89% Road/commuter

49% My child rides their own bike

26% Electric Bike

23% Cargo Bike

Concerns about bike theft

- In 2022, 99 bikes were stolen.
- In 2023, 86 bikes were stolen
- In 2024, 79 bikes were stolen.

"I bike often but do not like to leave my bike at destinations for fear of theft."

You can see a gradual decrease over this three year period. This is approximately 6-8 bike thefts per month.

40% of these thefts were unsecured bikes and 55% were stolen from homes, garages, or carports.

The city needs more bike racks

Key areas mentioned in the survey:

- Trader Joe's
- Parks
 - Burgess
 - Nealon
 - Willow Oaks
- Sharon Park Shopping Center
- Small markets on Willow
 - Newbridge and Willow
 - Willow and Ivy
- El Camino, particularly near Mama Cheli's/Cook's Seafood

"Effective bike parking for short-term users depends on two main factors: 1) proximity to the destination and 2) ease of use. Short-term parking is designed to meet the needs of people visiting businesses and institutions, and others with similar needs—typically lasting up to two hours. Short-term users may be infrequent visitors to a location, so the parking installation needs to be readily visible and self-explanatory." - APBP

86% of our survey respondents would walk between 0 to 2 blocks from their bike rack to their destination

The city needs better bike racks





Types of bike racks makes a difference

Cargo bike parking is lacking across the city

- Cargo bikes are large and heavy
 - They need larger parking spots and are difficult to maneuver onto sidewalks, into small spaces, etc.
- Particularly important for families accessing parks and city facilities (library, pool, gymnastics) or family-oriented businesses downtown (Cheeky Monkey, Rabbit's Foot, restaurants)

Location of bike racks makes a difference





Bike racks should be in safe and well-lit areas


"...without careful attention to user needs [the city] can create parking that excludes people because of age, ability, or bicycle type. This may result in people parking bicycles in other less desirable places or choosing not to bike at all.


Gold Standard!

Example: Burgess Park

Issues:

- Almost all wave (bad) rack types
- Some heavily used locations have NO racks
- Some heavily used locations don't have enough racks














Example: Burgess Park

Solutions:

- Either replace wave racks or compliment them with staple racks
- Add staple racks to any location that has none
- Add staple racks to any location that doesn't have enough








How should bike racks be requested?

When people note that bike racks are needed, how do they make that request to the city?

When broken down bikes linger on racks, how should that be reported?

Bonus: Network Safety and Map



Protected bike lanes help bikers feel safe.

Map and signage indicating safe bike routes and positions of bike racks will help riders plan trips.

Menlo Park bike network

I just want to acknowledge that I do bike sometimes, but I don't bike as much as I would if I felt safer on the roads.

Bonus: E-bike safety and Drivers Ed

E-bikes increase accessibility to larger regions of the city and more segments of the population

E-bike riders have a responsibility to understand safety rules on the road

"Getting rid of e-bikes for people without a driver's license."

""Children" should not riding e-bikes unless they are old enough to have a driver's license so they know the rules of the road."

Drivers have a responsibility to understand their role in road safety

Take Aways

More bike racks needed

- Bike Rack Types: 'staple' style rack
- Bike Rack Locations: close to businesses, easy to find (consistent), in well-lit areas

Bike Safety (while biking): Protected bikes lanes + more bike lanes

Education

- E-Bike Usage: Education and enforcement for minors
- Driver knowledge: Safety for all road users
