- Any event impacting traffic or intersections
- Any noise exceeding municipal code
- Attendance expected to exceed 150 people
- Community events

Permit Fees

- \$125 for minor event (block parties, private house event, less than
- \$250 for major event (requires street closure)

Time line

- 6 weeks for standard permit
- 60 days for events that require a noise permit or additional Police control

• 2019 Permits:

Approved 23 Permits (14 minor, 9 major)



- Increase access to ALL programs for ALL community members throughout ALL of Menlo Park
- Create a more competitive wage for Onetta Harris Community Center instructors, in turn raising the quality of programming
- Introduce a broader range of programming at Onetta Harris Community
 Center







Subsidized classes

- \$25 for a 10-12 week class
- Cap on instructor pay \$34 per session (typically 45-60 minutes)
- Typical business practice for instructor compensation
- Result is a lack of interest from major contract instructors and limited offerings for those needing subsidy

Current options

- One-to-One scholarship at Onetta Harris Community Center
- None for Burgess Campus
- "As a little girl growing up in the neighborhood, she said, she would study the city's activity catalog, unable to participate in the programs at the Burgess center because they were too expensive; programs at the Belle Haven location were cheaper, but were also, in some cases, cancelled." The Almanac, January 14, 2020







- Best practice of CPRS and NRPA "...low income groups should receive a subsidy in accordance with the Ability to Pay Principle, but other groups should pay for benefits they receive in accordance with the Benefit Principle." – NRPA Magazine January 2020
- Parks and Recreation Facilities Master Plan goals and guidelines accepted by City Council in October 2019. (One Menlo Park and 1.1.4 Equitable Access)
- Creates a competitive wage at Onetta Harris for contract instructors
- Consistent with the User Fee Cost Recovery policy and adapting to rapidly changing demographics
- Provides a subsidy for classes at Arrillaga Gymnastics Center, Gymnasisum and Arrillaga Family Community Center







- One-City Scholarship pilot program will allow Menlo Park residents to apply for a scholarship for any of CSD's fee classes at any location
- 5-10 new classes at Onetta Harris Community Center to be introduced at market rate this calendar year
- Classes throughout the City are eligible for scholarship
- To be sensitive to those not comfortable seeking financial assistance, the pilot program will not affect existing classes at Onetta Harris Community Center in year 1. Future changes to be evaluated.







- Administered through a partnership with Samaritan House
- Participants will make an in-person appointment to have eligibility assessed
- Must bring proof of any income of financial assistance from the past 30 days and proof of residence
- Sliding scale correlated to San Mateo County Income Limits for HUD-funded programs
 - Low (50%)
 - Very Low (38%)
 - Extremely Low (25%)
- Participants to be notified within 5 days of appointment
- Each household to receive \$500 of scholarship funds for the year
- Registration will need to take place in-person or via phone
- Great way to promote health and wellness to existing Samaritan House clients







- Up to \$40,000 to cover outreach, promotion, program administration through Samaritan House and City-wide scholarships
- Hourly staffing for 14 additional hours per week
