Roles and Responsibilities

The EQC is committed to helping the City of Menlo Park to be a leading sustainable city that inspires institutions and individuals and that is well positioned to manage present and future environmental impacts, including the grave threat of climate change

The EQC is charged primarily with advising the City Council on matters involving climate change, environmental protection, and sustainability

Commission Priorities

- 1) Climate Action Plan Advise and recommend on the next phase of implementation for the climate action plan
- 2) Climate Resilience and Adaptation Ensure that our most vulnerable communities have a voice in policies and programs to protect their communities from environmental impacts

Looking back Review of EQC activities

Priority #1: Updated Climate Action Plan Scope of Work for 2025 to 2030

- Updated scope of work for all six goals in the plan
 - 1. Building electrification
- 4. Reduce vehicle miles traveled
- 2. Electric vehicle adoption
- 5. Fossil fuels out of city ops
- 3. Electric vehicle charging
- 6. Sea level rise and flooding
- Some actions were getting more focus. Some were paused
- Some actions needed adjustment to fit new realities
- ► Each section was discussed by full group. Some subcommittees were formed to develop new recommendations
- ► Each section was updated according to new research or creative approaches used by other cities
- ► EQC finalized recommended updates to the Scope of Work in May 2024 and staff will present to city council in August 2024

Review of EQC activities

Priority #2: Climate Resilience and Adaptation

- Members of the EQC have been attending Belle Haven CCCT meetings regularly as private residents and hearing more direct resident feedback
- Climate changes today (heat, health, storms) has just as large an impact on our community as the impacts we're mitigating for that are happening over time (e.g. temperature rise, sea level rise)
- Comment example If it's 95 degrees this summer, where can I go to get cool and be protected from that heat?
- To further address these "here now" impacts, the EQC has recommended an expansion of CAP 6 from just sea level rise to a full suite of adaptation and resilience actions to protect our residents

Review of EQC activities

Priority #3: Urban Canopy

- City made Urban Forest Management Plan (UFMP) Tier 1 priority / budgeted as \$250,000 CIP project
- Staff update to EQC in Feb 2024 on creation of an UFMP
 - City has been consistently planting trees from 2018 to 2024
- ▶ Planning led by community coalition. Strong focus on Belle Haven
- Rationale: health impacts in Belle Haven, the example of East Palo Alto's UFMP, tree benefits - climate, health, community

Separately, in March 2024, EQC listened to its first heritage tree ordinance appeal - remove a coast live oak at 219 Durham Street
