## REBUTTAL TO ARGUMENT IN FAVOR OF MEASURE V

We agree about one thing: Menlo Park voters should decide the future of our City.

Measure V presents Menlo Park voters with a very important decision. Will Menlo Park welcome teachers and essential working families into our community or will we keep them out?

Measure V's argument tries to scare you by saying development will be out of control. In reality, Measure V will stop the Ravenswood School District from building 90 affordable homes for teachers at a time when local schools face unprecedented teacher shortages due to recordhigh housing costs. And that's not all.
